### WHAT IS THE COST OF A TYPICAL DSAR?

- The cost of a DSAR will be based upon:
  - The amount of time needed to manage the delivery (based upon the DPO day rate),
  - The amount of data needed to be included in the response and the amount of data that needs to be redacted (based upon the AI tooling costs).
  - The cost of any additional professional services to configure the AI Tool for any complex requirement (based upon the stated day and hourly rates).
  - This will vary from DSAR to DSAR.
  - We always aim to minimise the scope (as per guidance within the Data Use and Access Act 2025.)
